We are a charity providing specialist legal advice and representation to people living in Bristol and in some cases the South West & Wales.

Our solicitors and caseworkers work with thousands of people a year, changing lives by enabling people to keep their jobs, homes, income and independence.

We work in the following areas of social welfare law:

Housing - we can help with repossession, unlawful eviction, homelessness, anti-social behaviour injunctions, disrepair.

Employment - wages & pay, maternity & family rights, equal pay for men and women, unfair dismissal or contract terms, and Tribunals.

Discrimination - problems with employment, public services, shops and service providers because of age, race, gender, transgender, pregnancy & maternity, religion or belief, sexual orientation, ethnicity or disability, and access issues for people with disabilities.

Immigration & asylum - including a specialist solicitor for all children's cases

Mental health - help with Tribunals, managers' hearings, mental capacity, treatment, aftercare, nearest relative, unlawful detention.

Welfare benefits - we help with appeals against decisions on social security benefits, e.g. Employment and Support Allowance (ESA) and Personal Independence Payment (PIP).

Public law - challenging unfair decisions made by public bodies such as prisons, schools, councils, health services or the police. "My voice was heard" "I could not have done it without you" "You gave us peace of mind and confidence"
